- A. **Assume the contract/ assignment of Gila Ranch Road right-of-way, Grant #AZA31207 currently assigned to Dallas L. Self.**
- B. **Approve or deny the request by Dallas Self to enter into a Road Maintenance Agreement with the Town of Wellton.**

Mayor Deermer informed Mr. Self that the Town's Attorney has advised the Council that we have no legal authority to accept this road into our street system and no authority to enter into a Road Maintenance Agreement.

Mr. Self asked, where do we go now since the Town Attorney has given the Council this opinion? Mr. Self was still not satisfied. He doesn't agree with Mr. Engler's opinion. Mr. Self informed the Council that he will have to do more homework to convince the Council that Mr.


Engler is not correct. He is going to contact Mr. Claridge, who drafted the street maintenance agreement and he will contact Rick Myers for Pioneer Title Co. to get the right-of-ways confirmed. Mr. Self feels Don Engler's actions are malicious and if discovers that the Town does have these powers, he feels we should find another attorney to represent the Town.

Mr. Self also felt we should take this issue to a Judge and him decide who is in the right.
