4. **Discussion and possible action to enter into a Lease Agreement by and between Tri-Valley Ambulance Service, Inc. and the Town of Wellton for the use of premises located at 29118 E. Los Angeles Avenue, Wellton, Arizona for the purpose of providing the Town of Wellton and surrounding areas with an ambulance service for a month-month term.**

This will be a commercial lease agreement. There was discussion in regards to modifying the exit to Los Angeles Avenue and the possibility of sharing utilities. The Council will look at this again and modify the Lease Agreement if it becomes a reality.

Town Manager Rinehart reported that Representative Gosar would like to do a meet and greet on February 19, our next Council meeting; reported the progress of the bridge redecking project; it has been postponed to a later date; Jim Davies is working on the bid documentation for the Water Plant CDBG project and our WIFA grant is forthcoming. This grant will identify leaks at our Water Plant and make corrections.

There being no further business to conduct, the meeting adjourned.


