TOWN OF WELLTON COUNCIL MINUTES MARCH 19, 2013

Mayor James L. Deermer called the regular session to order at 7:00 p.m. on Tuesday, March 19, 2013, lead the pledge of allegiance and gave the invocation. Roll call was taken.

- Call To The Public We had two calls to the public requests:
- Mr. Doug Hoff informed the Council that the Coyote Wash Neighborhood Watch Group has been formed.
- Ms. Diane Umphress came in late. Ms. Umphress is the Executive Director of Amberly's Place, she attended this evening to report on the activities the organization is involved with. Ms. Umphress gave the Council and public a brochure and the Council received a spreadsheet with services and number served for each service.

7. Update and discussion of our Financial Audit for Fiscal Year 2011-2012.

Town Manager Rinehart informed the Council that situation that lead to our Auditors,

REDW, to fail to file the Town's annual audit with the Auditor General's office by the prescribed deadline. He further explained how it is being remedied. The Town will incur no fines or penalties and we have asked John Todd to solicit a new auditor for the Town.

8. Other Reports

Councilmember Bejarano reported that he met with Danette Dunn of Allied Waste in regards to recycling and he also reported that he was asked to speak at the Grand Opening of the AWC East County Campus and encourages everyone to go over and look around and felt it was a great asset to our community.

9. Manager's Report

- Town Manager Rinehart reported that he has been working with Allied Waste to get us a proposal for recycling and he has a meeting tomorrow with them so we will continue working with them.
- On our Booster Pump Station project, which is a CDBG Project, met last week and we set the dates for the pre-bid for April 17, 2013 and the final bid opening will be due on May 1. We have all of our documentation from the State saying we can proceed with the project
- Reported on a new YCAT program which is called the Wellton CAT. This program will offer door -to- door service within Wellton into Yuma starting Friday, March 22, 2013. This service is available on Fridays from 10:00 a.m. 2:00 p.m. for \$2. Contact Number is on the Web.
