# Call to the public:

**Lynette Layton:** She was thankful for the Fire Department and Police Department responding to her house on Sunday. The Fire Department responded with the ladder truck, she would like to see the Town equip the smaller vehicle for the Fire Department.

**Shirley Reynolds:** She would like the Council and audience to come to meetings without their cell phones and electronic devices.

**Sally Hawley:** She is requesting that if you are on paperless billing – do not send out a paper bill also. Questioned how we are on the investigation of the recent incidents in Coyote Wash.

#### **Department Heads**

**Police Department:** Town Manager Watenpaugh said the background check for the new Police Chief is almost completed. He also presented the monthly update for Wellton Police Department. Updated the Council on the burglary case and monthly stats.

**Magistrate and Court Department:** Magistrate Jones gave a report on the Magistrates Conference in Prescott as well at the monthly activity of the Municipal Court.

**Fire Department:** Chief Rivera reported on March and April statistics. He also thanked Lynette Layton for her kind words and will pass them on to the crew. The Wellton Fire Department will be participating in Water Day at Wellton Elementary School on Wednesday, May 21.

**Public Works Department:** Public Works Director Grant reported Butterfield Golf Course has closed for the season. Water Dog Day at ND & Katie Kline Pool was on Saturday, May 17 and there were over 100 attendees. The Town will be working on the County 12<sup>th</sup> Watering Systems and separating them off from each other to improve the watering. The Staff has been working on the Los Angeles Avenue weed abatement on Town property. The new Cemetery shade has been fabricated, it just needs to be painted and the awnings installed to be complete. It should be complete in a week or two. Request by Vice Mayor McCollough was presented for additional speed limit signs along County 11<sup>th</sup> Street. Public Works Director Grant will also discuss this with the Police Department for more enforcement.

### 1. Discussion and possible action to adopt the revised Animal Control Ordinance.

Town Manager Watenpaugh summarized the revisions in the Animal Control Ordinance. Vice Mayor McCollough would like to raise awareness of pet owners in the Town of Wellton as to what is expected of them.
