## Minutes of the November 4, 2014 Regular Meeting

Mayor James L. Deermer called the regular meeting to order at 7:00PM on Tuesday, November 4, 2014, lead the Pledge of Allegiance and Vice Mayor Cecilia McCollough gave the invocation. Roll call was taken.

### Department Heads

**Police Department:** Chief Jones presented the activity report for October. The driving simulator will be in Town at the Courthouse on November 19 – 20.

**Magistrate and Court Department:** Town Magistrate Jones gave the activity report for October.

**Fire Department:** Chief Rivera gave the activity report for October. The Response Truck was mobile on Halloween to offer candy inspection. The Station was also available as a candy inspection point. Both were very busy.

**Public Works Department:** Public Works Director Grant gave the current activity report. The new auto flusher arrived and will be installed in our water distribution system and new media installed in the last 2 filters. Butterfield Golf Course opened for the season on October 21. Christmas Tree Lighting will be on December 13 at West Side Park. The Sanitation trucks have had a couple of breakdowns and these have been repaired.

Motion made by Vice Mayor McCollough, seconded by Councilmember Jameson to approve Amendment #1 to our IGA/JPA 13-0003548-I with the State of Arizona regarding Coyote Wash Multiuse Path and authorize the Mayor and Town Manager to execute the document. Voice vote: 4-0-1. Motion carried.

Discussion and possible action to approve the request from Habitat for Humanity to hold their 3rd Annual Fundraising Golf Tournament at the Butterfield Golf Course, subject to including the Daily Green Fee of Twenty dollars (\$20.00) in the Tournament Entrance Fee and the Tournament Director select another date, other than January or February.**

- GYEDC – only executive board members are allowed to attend the meetings.
