Department Heads

Police Department: Chief Jones gave a report on the December 2014 activity. 2015 Grant funding for Stone Garden has been approved and he is on the Stone Garden Board. Received \$4,500 grant for Mobile Radio Unit. New Speed Trailer is up and running. With this unit there is a data recording function on the trailer and reports can be compiled from the statistical data. Friday, January 9 is Law Enforcement Appreciation (LEAP) Day.

Magistrate and Court Department: Magistrate Jones gave a report on the December 2014 activity. \$4,000 (roughly) for Municipal Court in December and of that, FARE has brought in \$878.

Fire Department: Chief Rivera gave a report on the December 2014 activity. 27 runs for December – 16 of which were during the day. 11 runs on the south side of the railroad tracks – no train delays.

Christmas Tree Lighting and Girls Softball Scrimmage (at Wellton School) were 2 activities the Fire Department participated in in December.

Public Works Department: Public Works Director Grant reported on activity for December 2014. Painting is ongoing (but almost completed) at the Water Plant. January 15 will be the kick-off meeting with the Coyote Wash Bridge Assessment. William Street is being spot patched. More non-locals calling for tee times in the afternoon at Butterfield Golf Course. Wellton World of Wheels Car Show on March 28, 2015. There were 2 bids received for the pool renovation. Sanitation pick-up is now back on schedule after the holidays. Tractor Rodeo is on January 17. Brownsfield contract has been forwarded on to ADOT. There was a question regarding the TTHM notification at the library, the issue is being addressed and is under control.

DISCUSSION AND ACTION ITEMS

1. Discussion and possible action to elect a new Mayor Pro Tem.

Mayor McCollough opened nominations for Mayor Pro Tem. Councilmember Deermer nominated Councilmember Bornt. Councilmember Bornt accepted the nomination. Councilmember Bejarano nominated Councilmember Jameson. Councilmember Jameson accepted the nomination.

Motion made by Councilmember Deermer, seconded by Councilmember Bornt to close nominations. Nominations were closed.

Mayor McCollough called for a voice vote. Voice Vote: 5-0. Councilmember Bornt was voted in as Mayor Pro Tem.

2. Approval of Minutes.

a. For the Meeting of December 2, 2014 (Regular Meeting).

Motion made by Councilmember Deermer, seconded by Mayor Pro Tem Bornt to approve the minutes for the Meeting of December 2, 2014 (Regular Meeting) as corrected. Voice vote: 4-0-1. Motion carried.

3. Second Reading of Ordinance #119, an ordinance of the Town of Wellton, Arizona, relating to the Personnel Rules and Regulations and adopting the 2014 Amendments to the Personnel Rules and Regulations "by reference" and discussion and action to adopt Ordinance #119.

Motion made by Councilmember Deermer, seconded by Mayor Pro Tem Bornt to adopt Ordinance #119, an ordinance of the Town of Wellton, Arizona, relating to the Personnel Rules and Regulations and adopting the 2014 Amendments to the Personnel Rules and Regulations "by reference". Voice vote: 5-0. Motion carried.

4. Discussion and possible action to accept or deny the Surplus Property bid.

One bid was submitted for the Request for Bids for the Surplus Property in the amount of \$2,000.00. We did have an Opinion of Value for the property from a local Realtor at a much higher value.

Three options were presented to the lone bidder. They selected Option #3 – a per square foot cost plus a land swap.

Motion made by Councilmember Deermer, seconded by Councilmember Bejarano to deny the Surplus Property bid. Voice vote: 5-0. Motion carried.

Motion made by Mayor Pro Tem Bornt, seconded by Councilmember Deermer to approve the Amended Surplus Property Bid Option #3, regarding Parcel #200-14-900. Voice vote: 5-0. Motion carried.

5. Discussion and possible action regarding Parcel #709-11-067.

Motion made by Councilmember Deermer, seconded by Councilmember Bejarano to allow Staff to make an offer to purchase Parcel #709-11-067 (small parcel of property between the Police Department and the Post Office). Voice vote: 5-0. Motion carried.

6. Discussion and possible action to accept or deny the ND & Katie Kline Pool Renovations bid.

Motion made by Councilmember Bejarano, seconded by Mayor Pro Tem Bornt to accept the ND & Katie Kline Pool Renovations bid. Bid was awarded to Majestic Pool. Voice vote: 5-0. Motion carried.
