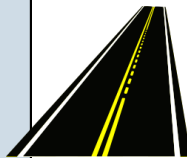

## Road Repair—Town of Wellton



Plans were in the works to repave William Street (Avenue 29E) from Napa Avenue north to Mountain View Avenue, as well as south from County 12th Street to County 13th Street next spring (date TBD). Another area to be reconditioned is County 11th Street from William Street (Avenue 29E) east to Avenue 28E.

The Town of Wellton and Yuma County had entered into an Intergovernmental Agreement (effective date January 1, 2017) for Road Maintenance.

Yuma County recently made some personnel changes that resulted in the re-scheduling of our proposed project until for later in the year.

## Yuma County Courts Limited Fine Reduction Pilot Program

People with unpaid or balance-due traffic tickets from Yuma County's seven municipal and justice courts have a one-time opportunity to clear their record through a limited fine reduction program. The Arizona Supreme Court and the Superior Court in Yuma County have announced that Yuma County's municipal and justice courts are currently conducting a one-time limited fine reduction program, which allows the courts to reduce certain qualified fines, penalties, and surcharges.

The courts are offering a 50 percent reduction on the amount owed on civil traffic cases that have been in collections for more than two years. The limited program starts Tuesday, February 14, 2017 and ends Friday, April 21, 2017.

To participate, eligible individuals must appear at the court during normal business hours to discuss their case with court staff. After the 50 percent reduction is applied, the participant must pay the newly reduced balance in full or enroll in a monthly payment plan. There is a minimum initial payment of \$55, which can be paid with cash, money order, or credit card.

Individuals whose driver's license has been suspended may be eligible for license reinstatement after clearing up their old ticket or committing to a payment plan. After court, the individual can visit the Arizona Motor Vehicle Division (MVD) for more information.
